

INVITATION TO BID

SR 948 MAIN STREET SCHOOL PEDESTRIAN CROSSING FOX TOWNSHIP, ELK COUNTY, PENNSYLVANIA

Fox Township is soliciting Sealed Bids for the SR 948 Main Street School Pedestrian Crossing project. Bids will be received at the Township Office, listed below, until 4:00 pm prevailing local time on July 6, 2022. The bids will then be opened and read aloud during the regular meeting of the Fox Township Supervisors at the municipal building located at 116 Irishtown Road, Kersey, PA 15846 at approximately 6:00 pm on the same day. It is anticipated that the successful bid will be awarded at this meeting. This project consists of upgrading an existing pedestrian school crossing. Work involves construction of concrete ADA curb ramps, flashing School Zone speed limit signs, flashing pedestrian crossing signs, electrical service, excavation, conduit, wiring as needed, pavement restoration and pavement striping.

The Issuing Office for the Bidding Documents is Keller Engineers, Inc., 420 Allegheny Street, Hollidaysburg, PA 16648. Prospective Bidders may examine the Bidding Documents at the Issuing Office on Mondays through Fridays between the hours of 8:00 am and 5:00 pm and may obtain copies of the Bidding Documents from the Issuing Office as described below.

Printed copies of the Bidding Documents may be obtained from the Issuing Office, during the hours indicated above, upon payment of a deposit of \$50.⁰⁰ for each set. Bidders who return full sets of the Bidding Documents in good condition (suitable for re-use) within 10 days after receipt of Bids will receive a full refund. Checks for Bidding Documents shall be payable to "Keller Engineers, Inc.". A non-refundable shipping charge amount will be applied and will depend on the shipping method selected by the prospective Bidder. Bidding Documents are available in portable document file (PDF) format at no cost and can be emailed to the prospective bidder. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office. All bidders must be registered at the office of Keller Engineers, Inc. to be eligible to bid.

An optional pre-bid conference will be held at 10:00 am local time on June 16, 2022, at the project site. Attendance at the pre-bid conference is highly encouraged but is not mandatory.

Prevailing Wages will not apply to this contract since expected bid amounts should be less than the \$100,000.00 threshold set by the grant funding. Bidders need to be PennDOT Prequalified. Fox Township reserves the right to reject any and all bids and to waive any and all informalities.
