Sealed Bids for the construction of the Roaring Spring Municipal Authority's proposed Waterline Replacement Project will be received at the office of the Authority at 616 Spang Street, P.O. Box 33, Roaring Spring, PA 16673, until 4:00pm local time on Wednesday, November 16th, 2022, at which time the Bids received will be publicly opened and read. The Project includes the open trench replacement of approximately 11,250 linear feet of 2", 6", and 8" water main; 3,000 linear feet of water service line; 12 fire hydrants (Including the hydrant lateral); 38 3", 4", 6" and 8" gate valves; 4 air release manholes/assemblies; 1 blowoff assembly, related appurtenances, and restoration. The Roaring Spring Municipal Authority reserves the right to reduce contract quantities at any time subject to available project financing.

The Issuing Office for the Bidding Documents is Keller Engineers, Inc., 420 Allegheny Street, Hollidaysburg, PA 16648. Prospective Bidders may examine the Bidding Documents at the Issuing Office on Mondays through Fridays between the hours of 8:00 am and 5:00 pm and may obtain copies of the Bidding Documents from the Issuing Office as described below.

Printed copies of the Bidding Documents may be obtained from the Issuing Office, upon payment of a deposit of \$150. Bidders who return full sets of the Bidding Documents in good condition (suitable for re-use) within 10 days after receipt of Bids will receive a full refund. Checks for Bidding Documents shall be payable to "Keller Engineers, Inc.". Upon request and receipt of the document deposit indicated above plus a non-refundable shipping charge, the Issuing Office will transmit the Bidding Documents via delivery service. The shipping charge amount will depend on the shipping method selected by the prospective Bidder. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office. Bid Documents are also available on compact disc or flash drive as PDFs for a non-refundable charge of \$35, including shipping. Documents are not available via e-mail.

A pre-bid conference will be held at 2:00pm local time on Tuesday, November 8th, 2022, starting at the Authority's office at the above address. Attendance at the pre-bid conference is highly encouraged but is not mandatory.

Bid security shall be furnished in accordance with the Information for Bidders. This project will be funded by PennVest and Davis Bacon Wage Rates, along with additional State and Federal requirements, will apply to all work.
