### **BLAIR TOWNSHIP WATER AND SEWER AUTHORITY 2023 CAPITAL IMPROVEMENTS COUNTRYVIEW DRIVE WATERLINE REPLACEMENT BLAIR TOWNSHIP, BLAIR COUNTY, PA**

Sealed Bids for the construction of the Blair Township Water and Sewer Authority's proposed 2023 Capital Improvements: Countryview Drive Waterline Replacement project will be received at the office of the Authority at 377 Cedarcrest Drive, Duncansville, PA 16635, until 10:00am local time on Thursday March 30, 2023, at which time the Bids received will be publicly opened and read. The Project includes the replacement of ~700 LF of 8" PVC water main, new valves and reconnection of existing services, along with related appurtenances and restoration.

The Issuing Office for the Bidding Documents is Keller Engineers, Inc., 420 Allegheny Street, Hollidaysburg, PA 16648. Prospective Bidders may examine the Bidding Documents at the Issuing Office on Mondays through Fridays between the hours of 8:00am and 5:00pm, and may obtain copies of the Bidding Documents from the Issuing Office as described below.

Printed copies of the Bidding Documents may be obtained from the Issuing Office, upon payment of a deposit of \$100. Bidders who return full sets of the Bidding Documents in good condition (suitable for re-use) within 10 days after receipt of Bids will receive a full refund. Checks for Bidding Documents shall be payable to "Keller Engineers, Inc". Upon request and receipt of the document deposit indicated above plus a non-refundable shipping charge, the Issuing Office will transmit the Bidding Documents via delivery service. The shipping charge amount will depend on the shipping method selected by the prospective Bidder. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office. Bid Documents are also available on compact disc or jump drive for a non-refundable charge of \$20, including shipping.

A pre-bid conference will be held at 10:00am local time on Thursday 23, 2023, starting at the Authority office at the above address. Attendance at the pre-bid conference is highly encouraged but is not mandatory.

Bid security shall be furnished in accordance with the Information for Bidders. This project will be funded by the Blair Township Water and Sewer Authority. Pennsylvania State Prevailing Wage Rates along with additional State requirements, will apply to all work.
