

**ADVERTISEMENT FOR BIDS**

**STORM SYSTEM INLET REPLACEMENT AND REPAIR PROJECT  
EAST CONEMAUGH BOROUGH , CAMBRIA COUNTY, PENNSYLVANIA**

**Sealed Bids** for the construction of East Conemaugh Borough's proposed "Storm System Inlet Replacement and Repair Project" **will be received** at the office of the Borough at 355 First Street East Conemaugh, PA, **until 7:00 pm local time on Wednesday July 19, 2023**, at which time the Bids received will be publicly opened and read. The Project includes fourteen (14) storm inlet replacements, one (1) new storm inlet installation and miscellaneous repairs to approximately ten (10) additional storm inlets; along with related appurtenances and restoration.

The Issuing Office for the Bidding Documents is Keller Engineers, Inc., 420 Allegheny Street, Hollidaysburg, PA 16648. Prospective Bidders may examine the Bidding Documents at the Issuing Office on Mondays through Fridays between the hours of 8:00am and 4:00pm and must obtain copies of the Bidding Documents from the Issuing Office as described below.

Printed copies of the Bidding Documents must be obtained from the Issuing Office, upon payment of a deposit of \$100. Bidders who return full sets of the Bidding Documents in good condition (suitable for re-use) within 10 days after receipt of Bids will receive a full refund. Checks for Bidding Documents shall be payable to "Keller Engineers, Inc.". Upon request and receipt of the document deposit indicated above plus a non-refundable shipping charge, the Issuing Office will transmit the Bidding Documents via delivery service. The shipping charge amount will depend on the shipping method selected by the prospective Bidder. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office. Bid Documents are also available on a thumb drive for a non-refundable charge of \$25, including shipping.

**A pre-bid conference will be held at 10:00 am local time on Wednesday July 12, 2023, at the Borough's Office located at the above address. Attendance at the pre-bid conference is highly encouraged but is not mandatory.**

Bid security shall be furnished in accordance with the Information for Bidders. This project will be funded by DCED and Pennsylvania State Prevailing Wage Rates, along with additional State/Federal requirements, will apply to all work.

The East Conemaugh Borough Council reserves the right to reject any and all bids and to waive any and all informalities.
