

## **ADVERTISEMENT FOR BIDS**

### **ACCESS DRIVEWAY**

#### **UNION TOWNSHIP MUNICIPAL AUTHORITY, MIFFLIN COUNTY, PA**

Sealed Bids for the construction of a new access driveway at the existing Union Township Municipal Authority wastewater treatment facility will be received at the treatment facility at **101 Coldwater Lane, Belleville PA 17004**, until **1:00pm** local time on **Wednesday March 20<sup>th</sup>, 2024**. Delivery services may be sent to the address above; however, early mailed bids must be sent to P.O. Box 5625, Belleville PA 17704. Bids received will be publicly opened and read at the Authority meeting at 3:00pm that day at the Union Township Offices. The Project includes the construction of approximately 1,050' of new driveway along with related earthmoving, stormwater piping, barrier stones, conduit for future use, and restoration.

The Issuing Office for the Bidding Documents is Keller Engineers, Inc., 420 Allegheny Street, Hollidaysburg, PA 16648. Prospective Bidders may examine the Bidding Documents at the Issuing Office on Mondays through Fridays between the hours of 8:00am and 5:00pm and must obtain copies of the Bidding Documents from the Issuing Office as described below.

Bidding Documents are available digitally by contacting the above Issuing Office. Printed copies of the Bidding Documents may also be obtained, during the hours indicated above, upon payment of a deposit of \$75.<sup>00</sup>. Bidders who return full sets of the Bidding Documents in good condition (suitable for re-use) within 10 days after receipt of Bids will receive a full refund. Checks for Bidding Documents shall be payable to "Keller Engineers, Inc.". Upon request and receipt of the document deposit indicated above plus a non-refundable shipping charge, the Issuing Office will transmit the Bidding Documents via delivery service. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

A pre-bid conference will be held at 10:00am local time on Wednesday March 13<sup>th</sup>, 2024, starting at the wastewater treatment facility at the above address. Attendance at the pre-bid conference is highly encouraged but is not mandatory.

Bid security shall be furnished in accordance with the Information for Bidders. This project will be publicly funded and Pennsylvania State Prevailing Wage Rates, along with additional State requirements, will apply to all work.

The Union Township Municipal Authority reserves the right to reject any and all bids and to waive any and all informalities.
