Sealed Bids for the construction of Roaring Spring Municipal Authority's proposed New Raw Water Pumping Facility project will be received at the office of the Authority at 616 Spang Street, Roaring Spring, PA 16673, until 4:00pm local time on Wednesday November 19, 2025, at which time the Bids received will be publicly opened and read. The Project includes **Contract 1 – General**: work covers the construction of a new raw water pumping station including a 24'x32 block building, a precast concrete pump vault, new raw water pumps and appurtenances, site piping, a chemical feed pump, demolition of the existing chlorine building/treatment well and abandonment of the existing distribution pumping station; and **Contract 2 – Electrical**: work covers an emergency generator set and electrical components associated with the above-described project.

The Issuing Office for the Bidding Documents is Keller Engineers, Inc., 420 Allegheny Street, Hollidaysburg, PA 16648. Prospective Bidders may examine the Bidding Documents at the Issuing Office on Mondays through Fridays between the hours of 8:00am and 5:00pm and must obtain copies of the Bidding Documents from the Issuing Office as described below.

Bidding Documents are available digitally by contacting the Issuing Office listed above. Printed copies of the Bidding Documents may also be obtained, during the hours indicated, from the Issuing Office, upon payment of a deposit of \$100.00. Bidders who return full sets of the Bidding Documents in good condition (suitable for re-use) within 10 days after receipt of Bids will receive a full refund. Checks for Bidding Documents shall be payable to "Keller Engineers, Inc.". Upon request and receipt of the document deposit indicated above plus a non-refundable shipping charge, the Issuing Office will transmit the Bidding Documents via delivery service. The shipping charge amount will depend of the shipping method selected by the prospective Bidder. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda (if any), obtained from sources other than the Issuing Office.

A pre-bid conference will be held at 2:00pm local time on Tuesday November 4, 2025, starting at the Authority office at the above address. Attendance at the pre-bid conference is highly encouraged but is not mandatory.

Bid security shall be furnished in accordance with the Information for Bidders. This project will be funded by the Pennsylvania Infrastructure Investment Authority (PennVEST) and the Roaring Spring Municipal Authority. Pennsylvania State Prevailing Wage rates, along with additional State requirements will apply to all work.
