ROARING SPRING BOROUGH 2026 STORMWATER IMPROVEMENTS ROARING SPRING, BLAIR COUNTY, PA

Sealed Bids for the construction of Roaring Spring Borough's proposed 2026 Stormwater Improvements project will be received at the Borough office at of the Authority at 616 Spang Street, Roaring Spring, PA 16673, until 11:00am local time on Tuesday, May 5th, 2026, at which time the Bids received will be publicly opened and read. The Project includes the replacement of ~160 LF of 30" stormwater pipe, 2 manholes, a new inlet, abandonment of an existing stone chase, shed and tree removal, along with related appurtenances and restoration.

The Issuing Office for the Bidding Documents is Keller Engineers, Inc., 420 Allegheny Street, Hollidaysburg, PA 16648. Prospective Bidders may examine the Bidding Documents at the Issuing Office on Mondays through Fridays between the hours of 8:00am and 5:00pm, and may obtain copies of the Bidding Documents from the Issuing Office as described below.

Printed copies of the Bidding Documents may be obtained from the Issuing Office, upon payment of a deposit of \$100. Bidders who return full sets of the Bidding Documents in good condition (suitable for re-use) within 10 days after receipt of Bids will receive a full refund. Checks for Bidding Documents shall be payable to "Keller Engineers, Inc". Upon request and receipt of the document deposit indicated above plus a non-refundable shipping charge, the Issuing Office will transmit the Bidding Documents via delivery service. The shipping charge amount will depend on the shipping method selected by the prospective Bidder. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office. Bid Documents are also available via email at no charge.

A pre-bid conference will be held at 1:00pm local time on Tuesday, April 28th, 2026, starting at the Borough office at the above address. Attendance at the pre-bid conference is highly encouraged but is not mandatory.

Bid security shall be furnished in accordance with the Information for Bidders. This project will be funded by Roaring Spring Borough through a Local Share Account grant provided by the Department of Community and Economic Development. Pennsylvania State Prevailing Wage Rates, along with additional State requirements, will apply to all work. Roaring Spring Borough has the right to reject any and all bids.
