

## ADVERTISEMENT FOR BIDS

### EAST CONEMAUGH BOROUGH, CAMBRIA COUNTY, PENNSYLVANIA VETERANS MEMORIAL PARK TRANSFORMATION – PHASE II and IIB

Sealed Bids for the construction of East Conemaugh Borough's proposed Veterans Memorial Park Transformation – Phase II and IIB project will be received at the Borough office at **355 First Street, East Conemaugh, PA 15909**, until **10:00am on Tuesday, August 18, 2026**, at which time the Bids received will be publicly opened and read. The Project includes **Contract 1**: the construction of a 9'x16' block restroom including water and sewer services, ~510 SF of new macadam walking paths, replacement of ~300 SF of existing concrete sidewalk and curb, concrete wall removal and grading, concrete step replacement, appurtenances and related restoration; and **Contract 2**: electrical for the general contract described above in addition to the purchase and installation of 5 lamp posts and outlets throughout the park.

The Issuing Office for the Bidding Documents is Keller Engineers, Inc., 420 Allegheny Street, Hollidaysburg, PA 16648. Prospective Bidders may examine the Bidding Documents at the Issuing Office or the office of the Authority described above on Mondays - Fridays between the hours of 9:00am and 4:00pm but must obtain copies of the Bidding Documents from the Issuing Office as described below.

Digital copies are available by contacting the Issuing Office. Printed copies of the Bidding Documents may be obtained from the Issuing Office, during the hours indicated above, upon payment of a deposit of **\$200**. Bidders who return full sets of the Bidding Documents in good condition (suitable for re-use) within 10 days after receipt of Bids will receive a full refund. Checks for Bidding Documents shall be payable to "Keller Engineers, Inc.". Upon request and receipt of the document deposit indicated above plus a non-refundable shipping charge, the Issuing Office will transmit the Bidding Documents via delivery service. The shipping charge amount will depend on the shipping method selected by the prospective Bidder. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office. Bidding

A pre-bid conference will be held at the Borough's office on **Tuesday August 4, 2026 at 11:00am**. Attendance at the pre-bid conference is highly encouraged but is not mandatory.

Bid security shall be furnished in accordance with the Information for Bidders. This project will be funded partially by East Conemaugh Borough and partially by a Greenways, Trails and Recreation Program (GTRP) grant through the Commonwealth Financing Authority (CFA). Pennsylvania State Wage Rates will apply to all work.
